#### **Dr. Rod Basler**



**o**dney S.W. Basler, M.D., attended the KUniversity of Nebraska at Lincoln after graduating as valedictorian of Plainview High School and transferred after his junior year to accept an invitation for early admission to UNMC. He was elected as a junior into Phi Beta Kappa, and was a member of the very first Arts and Sciences Student Advisory Board. After graduating from UNMC, Dr. Basler completed dermatology residency training at the University of Michigan and served on active duty with the U.S. Air Force. He then entered into academics as Asst. Professor of Internal Medicine at the University of Arizona. In 1978, he returned to Lincoln to begin a dermatologic practice with offices in Lincoln and Fremont, and for over 30 years, has continued to serve UN-L by providing dermatologic care at the

University Health Center, and consultation in dermatology to the Husker athletic teams. He is a member of the Board of Trustees of the U of N Foundation. In 2000, Dr. Basler was honored by his peers by being elected Chairman of the Advisory Board of the 12,000 member American Academy of Dermatology, and was nominated as Vice President of the national group. Dr. Basler served on the Board of Trustees of the Dermatology Foundation and as Chairman of the group's Annenberg Circle Committee and state Leaders' Society. He is an Adjunct Associate Professor at UNMC, mentoring medical, PA, and Nurse Practitioner students, and has also been a prolific writer, publishing over 70 articles and textbook chapters.

onorable Cloyd Clark is a retired County Judge for the Eleventh Judicial District in Red Willow County. He and his wife, Linda, have one son. Cloyd earned his B.A. and J.D. from the University of Nebraska.

His community and professional involvements include: Rotary, St. Alban's Episcopal Church; Nebraska Bar Association; National Council of Juvenile and Family Court Judges; High Plains Historical Society; McCook Arts Council, the McCook Community Foundation, former History Nebraska Trustee and President and Nebraska State Historical Society Foundation Trustee.

Cloyd helped found the Buffalo Commons Storytelling Festival — an event dedicated to telling the story of our life on the plains.

Except for time served in the Army, Cloyd has lived his entire life in Nebraska. He has a passion for Nebraska and its history. His mother's family came by wagon to the Norwegian community on Deer Creek, northwest of Holbrook. His father's family began businesses in McCook including the livery barn and a plastering company.

#### Harl & Kay Dalstrom



**T**rofessor Harl Dalstorm, Ph.D., is Professor Emeritus of History at the University of Nebraska at Omaha, where he retired in 2003. Dr. Dalstrom served on the faculty of UNO from 1963-2003, and chaired its History Department from 1971-1975. He has authored Eugene C. Eppley: His Life and Legacy (Lincoln: Johnsen Publishing Co., 1969), and A.V. Sorensen and the New Omaha (Omaha: Lamplighter Press, Douglas County Historical Society, 1988). In addition to numerous scholarly articles, Dr. Dalstrom also has done extensive work with historical societies, museums, and the Prospect Hill Cemetery Historical Site Development Foundation in Omaha.

Kay Dalstrom earned her B. A. in 1964 from Municipal University of Omaha (Now UNO), where she also undertook extensive graduate work in French and English. From there, Mrs. Dalstrom went on to a 30-year career at UNO's Department of Foreign Languages. Kay has also enjoyed a prolific career of research and publication, co-authoring numerous publications since the 1970's, focusing largely on Plains history, and in particular the history and culture of the Midwestern dance band era.

The Dalstroms are co-authors with Lawrence H. Larsen and Barbara J. Cottrell of *Upstream Metropolis: An Urban Biography of Omaha and Council Bluffs* (2007), which is considered the first scholarly history of our largest urban area and continue to work on various local and regional projects. Harl and Kay reside in the Ponca Hills area of North Omaha, and spend much of their summers in Minnesota and Canada. Reflecting their summer residence, they have written "We Were Not Worried at Dinner time": *The October 1938 Forest Fires and the Last Frontier in the Rainy River-Lake of the Woods Borderland* (2009).



## Tony & Tam Dworak



#### Dr. Don R. Gerlach



Con R. Gerlach, Professor Emeritus of History at the

University of Akron, Ohio, received bachelor's, master's, and doctorate degrees from the University of Nebraska from 1954-61, and was an instructor there before moving to the University of Akron in 1962. He retired in 1994, and returned to his hometown of Harvard, Nebraska in 2010, where he resides in the 1919 home that his grandparents acquired in 1929.

Dr. Gerlach has written numerous books and articles on Philip Schuyler and the American Revolution, and other subjects of early American history, such as Samuel Johnson of Connecticut – an Anglican convert and missionary, and first president of King's College, which became Columbia University.

While in Nebraska, he has contributed articles for the Clay County Historical Society on numerous subjects, including a War of 1812 veteran buried in the Harvard Cemetery, and the five generations of Gerlachs in Clay County since 1886. He has contributed to or written texts for 4 State of Nebraska historical markers in Harvard,

out of a total of 6, a number that is only matched by Willa Cather's hometown of Red Cloud.

Always willing to fight for historic preservation, Dr. Gerlach recently led a drive to rescue Harvard's historic jail house from dilapidation – a building over 100 years old and featured in David Hendee's *Nebraska; 150 Years Told Through 93 Counties* (2016). The jail house received national publicity in 1943 when an enterprising teenager bought it for back taxes and then "sold" it to ventriloquist Edgar Bergan's Charlie McCarthy for \$10,000 to help fund the purchase of a new ship for the U.S. Navy.

Dr. Gerlach is currently working on behalf of the Harvard Community Club collecting and writing articles for updating Harvard, Nebraska! 100 Years +2 (1973), in anticipation of the city's sesquicentennial in 2021-22. In gratitude for his education, he has endowed the Gerlach Professorship of Early American History at the University of Nebraska Foundation.

Butch graduated from Peru State College with a degree in Industrial Arts Education. He taught in the Lincoln Public Schools before going into business on his own.


After graduating from UNL, Dobey taught elementary physical education in the Lincoln Public School system for 40 years.

Artin A. Massengale is President Emeritus of the University of Nebraska, Chancellor Emeritus of the University of Nebraska-Lincoln, Founding Director Emeritus of the Center for Grassland Studies and Foundation Distinguished Professor Emeritus. Dr. Massengale came to the University of Nebraska from the University of Arizona in 1976 as the Vice Chancellor of the Institute of Agriculture and Natural Resources.

Ruth A. Massengale graduated from the University of Wisconsin–Madison with a B.S. degree in Home Economics education and taught in the public schools both in Wisconsin and Arizona. She retired from teaching and became a Household Executive before serving as first lady of the University of Nebraska.

Dr. Massengale earned his B.S. degree from Western Kentucky University and his M.S. and Ph.D. from the University of Wisconsin– Madison. Prior to Nebraska, he was the associate Dean of the College and Associate Director of the Arizona Agriculture Experiment Station. He is a highly accomplished scholar, researcher and administrator, and has received numerous awards and recognitions for his work. Dr. Massengale has provided leadership at all levels of university administration, and has served as chair of the College Football Association (CFA), the President's Commission of the National Collegiate Athletic Association (NCAA) and the U.S. Secretary of Agriculture's National Advisory Board for Research, Education, Extension and Economics.

Michael and Christie Nelson were career journalists, engaged professionally in the writing, editing and publishing of news stories, and so helped craft what is sometimes called "the first draft of history."

They are University of Nebraska graduates. They met in the newsroom of The Kansas City Star, and married in 1984.

Christie, a native of Ogalala, was the assistant editor of The Star's Sunday magazine, and a columnist for it for 25 years.

Michael was The Star's assistant managing editor.

They returned to Nebraska in 2008 when he was named editorin-chief of the Lincoln Journal Star, from which he retired in 2012.

They have been trustees of the Nebraska Historical Society Foundation since 2013. Michael served as its president from 2014 through 2017.

## **Diane Oldfather**



Diane Oldfather of Lincoln is a long-time leader, supporter and friend of the NSHS Foundation. Her late husband, Charles Oldfather (1927-1998), served as president of the Foundation from 1991-1994.



im and Gail have spent their entire careers working in the field of American history, Jim at the Nebraska State Historical Society (NSHS) in Lincoln, and Gail at the NSHS and at the private, nonprofit Museum of the Fur Trade (MFT) in Chadron. They have established an endowment fund at the Nebraska State Historical Society Foundation to support the ongoing work of the several divisions of the NSHS.

James E. Potter (1945-2016) grew up on a Franklin County, Nebraska, farm and graduated from Wilcox High School. After his graduation from the University of Nebraska-Lincoln (UNL) in 1967, he began working at the NSHS as assistant state archivist, later serving as state archivist, and then served as director of publications and editor of *Nebraska History*. At the time of his passing on August 6th, 2016, he was the senior research historian in the NSHS publications division.

Gail DeBuse Potter was born in Omaha and graduated from Burke High School and UNL. In 1973 she joined the NSHS museum collections department as registrar. She was the museum collections manager and National Graves Protection and Repatriation Act coordinator for the NSHS at the time of her appointment as director of the MFT in 1997. Gail retired from the latter position in 2014.

Both of the Potters have authored or edited several books and numerous journal articles published by their respective institutions or other publishers. Having gained their livelihood and much enjoyment from "doing history," they decided it was appropriate to support the NSHS, Nebraska's flagship historical organization, which has been central to their careers.

#### Bruce and Sandra Rippeteau

At CWRU and U Az, he became a prehistorian, the first ever to have been State Archaeologist of two states (SC and CO), and later vice-president of a Petroleum Information Corporation Division. In Columbia, SC Bruce was president of the Downtown Club, the 20th largest of 34,000 worldwide, and co-founded Celebrate Freedom Foundation remaining President-Emeritus. Retired with Sandra to Lincoln, he is the co-founder of the Anthropology Department at UN-Lincoln's Alumni Friends and Advisory Board, and especially admires the NSHS Foundation and History Nebraska.

Sandra Rippeteau is a 5th generation native of Nebraska, born in Grand Island and educated in Lincoln at Lincoln HS and the University of Nebraska (1968). Sandra was "Miss Nebraska Civil Defense" in 1965.
