Statewide Grant Funding Preferences: Preference is given to non-profit organizations operating in and serving local communities. Grants typically range from \$100 to \$5,000. The main focus areas for grant distributions from the statewide grants program will assist local historical efforts on the part of historical societies, museums, archives, libraries, etc. Grants should be for core educational, preservation and interpretive purposes. Examples of this would be: collection preservation, building maintenance repairs and improvements, expansion of school visits or field trips, exhibit production, support for funding traveling exhibits and speakers, support for attending workshops and programming and publications.

Application Info and Deadlines: Submit completed application with any supporting material by April 30, 2021. Grantees will be notified on June 1, 2021.
