**The Foundation:** The Nebraska State Historical Society Foundation raises money to support the cause of Nebraska history. The Foundation solicits funds and support from individuals and organizations, across the state and beyond, who value Nebraska's unique heritage and wish to play a personal role in ensuring that Nebraska's history will be accessible to future generations. The Foundation is a 501(c)(3) not-for-profit corporation, TIN: 47-6000332.

**Statewide Grant Funding Preferences:** Preference is given to non-profit organizations operating in and serving local communities. Grants typically range from \$100 to \$3,000. The main focus areas for grant distributions from the statewide grants program will assist local historical efforts on the part of historical societies, museums, archives, libraries, etc. Grants should be for core educational, preservation and interpretive purposes. Examples of this would be: collection preservation, expansion of school visits or field trips, milestone events or festivals, youth and family programming, exhibit production, support for funding traveling exhibits and speakers, support for attending workshops and programming and publications.

**Application Information and Deadlines:** Submit completed application with any supporting material by April 30, 2024. Grantees will be notified in June, 2024.
